 - We also gather member input for the purpose of formulating recommendations and for the development of the Triennial Education Plan
- Role of Regional Education Officer (REO) in regional committee
 - o Prepare courses for the PSAC in collaboration with REOs from other regions
 - o Courses are the same across the country, with local variations for relevancy.
 - O Act as resource person for Education Committee.
 - O If the Education Committee wishes to request a new course, the REO must first verify if the PSAC-NCR has the budget to offer a new course

 - Chantal suggested that a presentation could perhaps be made to the Regional Executive
