- Education on Turtle Island expectations for course did not meet this, issues with the facilitators. 3 staff members, 2 aboriginal instructors, it felt like we were locked in. Lot of arguments and side discussions (indigenous housing). Attendees left upset. You were not allowed to ask questions until the end of the day (no time to ask at the end of the day). Role playing. Scolded by the facilitators. Told that they were rude. They were spoken at, not encouraged to engage. Told to raise our hands if we owned our home, then if we don't own the land lower your hand, those who had their hand up were told to give the land back. They were told to will it back to them. They were not allowed to be allies, now they have a bad taste in their mouth. Was there discussion on Unionism and Turtle Island. This did not feel like an advanced course.
