	Regional Coordinator Report
	While the Regional Coordinator was unavailable, this report was presented by the a/Regional Coordinator, Elisabeth Woods.
	Elisabeth noted that there is lots of work happening in NCR education, organizing around hybrid work and more French education opportunities.
	Questions
9:35 AM	Dave Lanthier asked about the new NCR policy of only having staff support and technical support for 4 in-person meetings each year. Elisabeth noted that staff are there to provide support but that committees should be able to function on their own with staff only acting as support. • Chair highlighted that per the NCR's by-laws, committees are only mandated to meet 4 times per year. Having staff support at more meetings than this is not the most efficient use of staff resources. Instead, we should be investing those resources in empowering members to self-organize. Some ways we are encouraging that self-organization include a Zoom account that committees can use for their own meetings
	and request forms for rooms. Dave Lanthier asked about roles of individuals when it comes to committees and the reimbursement process. • Chair noted that the process is being updated and that changes are made as the REVP Office receives feedback from users.

9:48 AM	Regional Executive Vice-President Report There was a 3-week delay before the new Regional Executive Vice-President (REVP) was

There has been a lot of work around the hybrid work campaign and many governance meetings including the Alliance Executive Committee (AEC) and National Board of Directors (NBoD). The REVP has been doing a lot of collaboration with other unions, particularly CAPE.



The REVP Office is currently prioritizing member reimbursements and making sure purchases are clearly tracked in the bookkeeping software. When a committee needs to make a large purchase, the REVP asks that they work together to coordinate payments and avoid out-of-pocket expenses for volunteers. The REVP Office is working establish clearer processes for these kinds of administrative pressures.

Bargaining:

Best Theratronics and Fort Simpson are currently on strike with Best Theratronics' strike lasting more than 5 months.

Staffing:

There has been a vacancy in the Regional Political Communication Officer's position with intermittent support from PSAC National Communications. On August 6, Lorna Munger took a 3-month term in the role. The staffing process for a new Regional Political Communications Officer is underway. On August 21st, 2025, Dana Ouelette joined the REVP Office as the acting Executive Assistant (EA) for a 1-year term. Dana was formerly the EA to the Regional Coordinator NCR.

Events:

Capital Pride: Thank you to Christina and Sonia from the Ottawa Area Council, as well as Lydia and Charles from Pride Committee, for their work on the PSAC delegation. The collaboration between the committees made a huge difference and the event was a success!

Labour Day Parade: Thank you to the Ottawa Area Council for organizing the PSAC-NCR delegation. The REVP office rented an ice cream truck which was a fun way to mark the day. Unfortunately, we learned that vehicles were not allowed to enter the parade only when we arrived at City Hall. There were also issues around timing, marshalling and police escorts. With this said, there were no major incidents, and we were welcomed by the community. Going forward, we will need to discuss safety and how we organize and collaborate with the Ottawa District Labour Council (ODLC).

Questions:

Dave Lanthier noted poor existing relations with the ODLC, which needs to be repaired and strengthened.

Dave Lanthier asked about whether there had been allocations made at the NBoD and AEC levels regarding funds for people that want to organize on telework. During National Convention, delegates approved \$1.5 million for a national campaign on the Return to Office Mandate. The National Strategy has not been rolled out yet. Any purchases related to the campaign are being discussed with members of the regional executive so that it is member-led.

	 Jennifer Tattersall asked about the state of finances in the region. Chair noted that expenses in QuickBooks were not tracked or recorded clearly. This has created some documentation challenges with regards to the regional finances. The Regional Treasurer was not present during this NCRC meeting to speak to this further. Diane Girouard expressed upset at the impression that the past Treasurer had not done their work properly. Chair clarified that the bookkeeping was not the responsibility of the regional treasurer and that new systems were being put in place as a response to concerns raised by delegates at the NCR AGM in June. Gilles Lavigne agreed that as Alternate Regional Treasurer, he is doing the work to get things done.

- Ottawa Area Council (OAC):
 - The AGM in March saw the acclamation of Ruth Lau MacDonald as Chair, and Ruth stepped down in June when she became REVP for the NCR. At this time, Jade Conrad was appointed as Interim Chair. In October, Jade stepped down



- as Interim Chair and Gord Marshall was appointed as incoming Interim Chair until the AGM in March 2025.
- o In April, the OAC attended the National Day of Mourning delegation organized by the regional Health and Safety Committee.
- OAC donated money to Punch Up Collective for their May Day event but did not take part directly.
- o In May, the OAC was involved in a shared cost initiative with the regional Health and Safety Committee in May for first aid courses for the region.
- o In May, the OAC also organized a delegation to the Rainbow Rally in Ottawa and organized first aid and marshal support for the rally, protesting in support of 2SLGBTQIA+ members.
- In May, the OAC developed 3 subcommittees: the RT(N)O subcommittee in support of telework, the Capital Pride subcommittee, and the Labour Day subcommittee.
- o These subcommittees were focused on member-to-member engagement and connection with other organizations and unions in the region.
- From June to October, the committee was busy with supporting the activities
 of its 3 subcommittees, developing a new event with the CNIB, offering
 financial solidarity support to member-led programming and picket lines in
 the region, and tying PSAC closer to the union movement in Ottawa and
 nationally.
- Ottawa Regional Women's Committee (ORWC):
 - The committee was represented at RT(N)O rallies, Capital Pride and Labour Day parades.
 - The committee has made donations to the NPF and Best Theratronics picket lines.
 - ORWC was able to fund 4 members to attend a symposium on collaborating to respond to and prevent harassment and violence at work in Montreal. It was an interesting event where members took away a lot of information. They will do a teach-back to their members.
 - o ORWC attended the Take Back the Night rally and attended the rally hosted by Families of Sisters in Spirit on October 4.
 - o In November, they will be hosting a screening of Polytechnique to honour the National Day of Remembrance and Action on Violence Against Women. Free tickets will be available on Eventbrite.
 - o The ORWC is developing a cookbook project and is asking committee members to submit a recipe and a short story. This project will celebrate the diversity of the committee.
 - The ORWC is moving from a terms of reference framework to a bylaw framework.
 - o They would like to see more solidarity between committees. They are seeing some more progress on this, but they are hoping to see an all-committee meeting in winter 2025 for the groups to discuss how they can work together.



- Health and Safety committee (HSC):
 - The next meeting will be the Annual General Meeting (AGM) on November 20.

 New members of the executive will be elected there.
 - The HSC supported a callout for the National Day of Mourning held on March
 28. They will continue that support for 2025.
 - The committee agreed to purchase 12 first aid kits for each of the regional committees to support their activities and in-person meetings.
 - HSC, in collaboration with the OAC, offered standard first aid for members in May.
 - o The committee is currently working on a regional health and safety conference for 2025.
 - o HSC is preparing a CLC challenge for members of the committee.
 - o The committee executive is working on their budget for the next cycle.
 - The HSC is inviting activists from all the regional committees to speak to the health and safety committee, as well as organizing guest speakers from Parliament.

• Education Committee:

- o In July, 16 members from UHEW, CEIU, UTE and CIU attended a pilot course for suicide prevention and intervention offered by Living Works. The training was held at the Gatineau Office, and participants developed new skills and reinforced existing connections with other members. 7 members of the Education Committee were present. It was a great success.
- o The executive met several times and exhibited great collaboration between members.
- o In August, we saw the completion of the union school with more than 120 registrants and 100 attendees. It took place at the Hilton Lac Leamy, and we are looking to continue the interest built by the PA strike and union school.
- o The September meeting showed a 46% increase from last year's attendance, and the October meeting had a 41% increase over last year's attendance. We are happy to see new people getting involved and coming to these meetings.
- o On October 11, James met with the Quebec Education Committee Chair and a member of the Fédération des travailleurs et travailleueses du Quebec (FTQ) to discuss member-led education and mobilization in union spaces.
- On October 21, Gord and James met with members of the Education Committees from another region to discuss their approaches and learn what are the best practices, missed opportunities and challenges in other regions.
 Understanding how member education works in other regions is a priority for the committee.
- The education retreat is set for November 16 and 17 in Ottawa. There are 9 confirmed registrants. The retreat will build the plan for the next cycle for the Education Plan.



- James is continuing to consolidate all the upcoming course offerings and send it to committee members and the regional executive to disseminate this information.
- o The committee is looking to leverage the Education Program and continue to build the knowledge and experience of the education space of PSAC. We want to get our members involved in co-facilitation and get them more involved in education in the region.
- Members with Disabilities Access Committee (MDAC):
 - MDAC is offering Safe Talks, a suicide support course, at the next MDAC meeting in November. The course is free for all members, and there are 50 seats available.
 - o The MDAC meeting in December will be an event to mark International Day for Persons with Disabilities featuring a Paralympian as guest speaker.
 - Karen asked Ruth whether mental health first aid will be offered by the region by the end of the calendar year, as had been previously discussed.
 - Chair has a meeting with Elisabeth Woods to determine a path forward and how to keep the momentum up for this project. Chair appreciates MDAC's leadership on these important skills for activists in our region.
- Indigenous Action Circle (IAC):
 - O Chair congratulated the IAC for organizing a walk for September 30, National Day for Truth and Reconciliation. The REVP NCR is looking to work more closely with the IAC and provide more support for these activities for the future.
- Racially Visible Action Committee (RVAC):
 - In February, RVAC celebrated a Black History Month event, which was hosted virtually to celebrate and honour Black Canadians and people of African descent.
 - o In August, RVAC hosted an Emancipation Day event in-person to mark the anniversary of the abolition of slavery across the British empire.
 - PSAC NCR did not promote the event for Emancipation Day as much as events for other committees were. It is a lesson learned and will be addressed moving forward.
 - o In December, there will be an International Human Rights Day event on December 12. There will be guest speakers and highlight the importance of human rights and the importance of fighting against racism.
 - o RVAC has been diligent in their budgeting and has budgeted directly to the end of this cycle.
- Pride Committee:
 - o No updates.
- Young Workers Committee:
 - There is a fundraiser being co-sponsored with the REVP NCR's office,
 Operation Come Home's "A Night on the Rideau".
